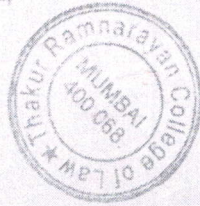

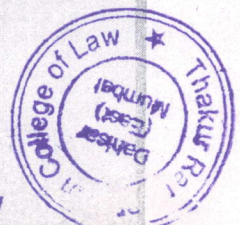

The meeting was conducted on 08 January 2022 through GOOGLE MEET and was convened between 11:30 AM to 12:30 PM. Dr. A.K. Singh, Principal, opened the meeting with a welcome speech for all the members, faculties and student representatives. Thereafter the following was discussed in the meeting.

1. TO READ AND IF FOUND CORRECT, APPROVE MINUTES OF THE MEETING OF THE COLLEGE DEVELOPMENT COMMITTEE HELD ON 27 FEBRUARY 2021

The minutes of the last CDC meeting held on 27 February 2021 were presented which were approved and adopted by the members.

2. ACTION TAKEN REPORT

Asst. Prof. Rajwant Rao was invited to discuss the Action Taken Report on the basis of suggestions which had been observed by the attendees at the previous College Development Committee meeting which was convened on February 27 2021. The following was discussed:

- Adv. Punit Chaturvedi's observations were to increase focus and emphasis on practical training and aspects of law. For the same, the Placement Cell provided internship opportunities to our students to expose them to the practical aspects of law. Moreover, the Placement Cell also conducted training and workshop programmes for the students to enhance the practicalities associated with law.
- Library – Following suggestions given in the previous CDC, emphasis was placed upon reference and reading books as well as research journals to hone writing and research skills in law. All students are given access with Manupatra so that they are able to continue to research even through remote access.
- Prof. N.M. Rajadyksha's suggestions were to increase focus on legal aid services and providing them to the marginalised groups. Asst. Prof. Rajwant Rao informed the attendees that the Legal Aid Clinic is convened every Saturday to provide legal aid services to those in need. The Clinic has also entered into collaboration with the NGO Global Care Foundation to work towards providing legal assistance to the weaker sections of the society. Workshops were also conducted by the Clinic to raise awareness amongst the students.
- Dr. Chaitaly Chakraborty's suggestions on strengthening practical knowledge of students was acted upon. Accordingly, series of practical training lectures were regularly convened from time to time to hone skills of students.

3. SPECIAL INVITEE'S BUDGET STATEMENT

Since Mr. Chetan Rathod, the Special Invitee, was not available for the meeting and was granted leave of absence, Assistant Professor Ms. Urmila Chauhan, was invited for making the budget statement. Ms. Urmila Chauhan discussed the income and expenditure accounts and the estimated budget for the Academic Year 2022-23.

4. GUEST LECTURES

Assistant Prof. Rajwant Rao made his presentation on the various guest lectures that have been organized by the college including sessions delivered by Dr. Ashutosh Acharya, Dr. Anindhya Tiwari, Mr. Vikranta Barsay, Dr. Bipin Kumar, Adv. Pooja Shah and Dr. Mandeep Kumar. Asst. Prof. Rao also informed the members of the different topics that were covered as part of these guest lectures ranging from tax laws, tribal rights in India, trial proceedings, intellectual property rights, negotiable instruments and international criminal law.

5. CO-CURRICULAR ACTIVITIES

Assistant Prof. Rajwant Rao then addressed the attendees on the various co-curricular activities that have been conducted by the College with focus on participation and achievements of the students in moot court activities.

Mr. Rajwant Rao informed all attendees that various teams had represented TRCL at national level trial advocacy competition, international and national level moot court competition as well as ADR competitions. He also informed all attendees about the achievements of students in moot court activities including winning international and national level moot court competitions as well winning best speaker and mediator awards. Mr. Rajwant Rao also informed about the success of TRCL's annual festival "Lex Communique" which was conducted in March 2021. Assistant Prof. Urmila Chauhan continued to inform the guests about other achievements in co-curricular activities such as participation and achievements of students in activities conducted by the Vidhi Chatra Sansad such as turncoat debate competition, Asian Parliamentary Debate competition and 1st British Parliamentary debate competition on contemporary topics cutting across politics, law and international relations such as those on India's stand with Taliban in Afghanistan.

Ms. Urmila Chauhan also informed the attendees about the 1st Intra-College essay writing and slogan writing competitions organised by the Magazine Committee on diverse topics such as environmental law and protection of rights of women. The attendees were also apprised about the release of Vidhi Varta, the quarterly newsletter of TRCL released by the Magazine Committee. Ms. Chauhan also discussed the Legal Awareness Program- Introduction to forensic evidence and its applications in trials that was conducted by the Legal Aid Clinic.

6. EXTRA CURRICULAR ACTIVITIES

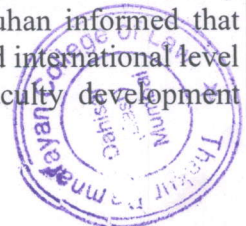
Assistant Prof. Urmila Chauhan appraised the guests on the National Law Day Celebration which was conducted physically on campus after a gap of almost over a year which was a success. Celebrations of Hindi Diwas as well as Teacher's Day were also conducted. Moreover, the Legal Aid Clinic also conducted series of lectures on practical aspects of law to hone understanding of students with emphasis on critical thinking, research and writing.

7. STUDENT ACHIEVEMENTS

Ms. Urmila Chauhan discussed the achievements of our students across the B.L.S./LL.B. and LL.B. programmes. Students had achievements in different activities such as poetry writing competition, policy drafting competitions, debate competitions, research and publications. Apart from achievements, many students had also participated in other competitions such as policy presentation, MUN, music instrumental competition and debate competitions.

8. FACULTY DEVELOPMENT & CAPABILITY ENHANCEMENT PROGRAMME

Ms. Urmila Chauhan informed the attendees about the achievements of faculties and various faculty development and capability enhancement programmes undertaken. Ms. Chauhan informed that faculties of TRCL had achievements in research and publications at national and international level as well as in conferences, seminars, paper presentation, workshops and faculty development programmes.



9. RESULT ANALYSIS

Ms. Urmila Chauhan analysed the results for the guests with a special mention for the 100% results for the 56 students from the LLB batch (2021) from TRCL.

10. PLACEMENT ACTIVITIES

Ms. Urmila Chauhan discussed the activities undertaken by the Placement Cell which focused on training and capability enhancement. These included workshops and capability enhance programmes, including webinars on Intellectual Property Rights. Ms. Chauhan also apprised about the various job opportunities that were secured by students with advocates, law firms and in house legal counsel for corporate houses.

11. LIBRARY & MANUPATRA

Ms. Urmila Chauhan informed the attendees of the gradual increase in the number of books that are available in TRCL library along with the initiative taken to provide electronic Manupatra access to our students and faculties. Ms. Chauhan noted that TRCL currently has 2113 books and 44 books had been purchased in 2020-21. Moreover, for providing access to our students of Manupatra, webinar was conducted on 25 October 2021 by the Manupatra team to help students understand how to use Manupatra.

12. FUTURE PROSPECTS

As part of the future vision and prospects, Ms. Urmila Chauhan informed the different activities which are being currently worked upon including the upcoming Lex Communique in February 2022 and proposed certificate courses on Media Law. Lex Communique 2022 was contemplated to be held physically but due to restrictions, the event will be conducted virtually and will include Trial Advocacy and Youth Parliament. Ms. Urmila Chauhan invited the student representatives to put forward their suggestions during which Mr. Shyamdhara Upadhyay and Ms. Shravya Shetty indicated that they do not have any current suggestions and will indicate the same to the faculties in the future. Proposal for Establishment of IQAC in TRCL was recommended wherein, Prof. Shovonita Acharjee was appointed as the Coordinator of IQAC

Observation from Attendees:

- Prof. N.M. Rajadyksha appreciated the efforts and achievements of TRCL students and staff especially in light of the pandemic and restrictions that are being imposed. Prof. Rajadyksha encouraged the faculties and students to continue making progress and suggested continued emphasis on research and writing for students and faculties and continued access to library.
- Adv. Punit Chaturvedi also appreciated the efforts of TRCL and the activities conducted despite the restrictions and encouraged the same to continue in the future.



Memorandum of Understanding between Thakur Ramnarayan College of Law (TRCL) and Afroz Shah Foundation.

This Memorandum of Understanding (MOU) is made at Mumbai on
(13/09/2023)

Between

Afroz Shah Foundation, a charitable foundation, registered under the section 8 of the Companies Act 2013, having charitable objects to protect and preserve environment including but not limited to water, land, air, outer space, oceans, lakes, rivers, water bodies, trees and forest; and to implement sustainable development goals (SDG's) of United Nations (UN) and having its registered address at B-1010, Everest Apartment, J.P. Road, OPP. Ganga Bhavan, Versova, Andheri West, Mumbai 400061.

and

Thakur Ramnarayan College of Law (TRCL) which is located in the vibrant Financial Capital of India is a new GEM in the necklace of Thakur Education Group and imparts a rigorous and multi-disciplinary legal education with a view to producing world-class legal professionals, scholars and public servants.

TRCL empowers its students with knowledge, skills and vision to meet the challenges and opportunities of a rapidly changing world.

TRCL's expert faculty comes from across the spectrum of legal careers and engages in critical study that contributes to public debates both in class and country. TRCL is committed to provide quality education to learners at all levels. Baked by visionary spirit of the Thakur Group of Education, TRCL brings to Dahisar, a world class state of the art infrastructure and amenities for the new generation of students.

Both the Parties,

Recognizing that the Planet Earth and Mother Nature are facing existential threat due to Pollution - Air, Water and otherwise, Global Warming, Marine debris, Irresponsible Consumption, Use and throw culture, Human behaviour which is in direct conflict with Mother nature and with other species;

Recognizing that this existential threat to our planet – is inextricably linked with human behaviour and human choices as a consumer, and that threat to environmental quality affects the health and wellbeing of individual citizens and of other species.

Recognizing that Healthy and fit planet contributes to UN Sustainable development goals (SDG'S) and to the health and environmental security consideration of the nation;

Recognizing that Article 51A (g) of the Constitution of India casts a duty on the Citizen of India to protect and preserve Mother Nature;

Recognizing that the young citizens are the leaders of the present and the future and have an important role to play in mitigating Global Warming and to beat Pollution including Plastic pollution;

Recognizing that Afroz shah Foundation has the necessary experience, expertise, perspective and the collaboration between the parties can uniquely assist and mitigate the problem of Global warming, Plastic Pollution, Marine debris and implement Circular Economy;



Recognizing that the parties have an important role to play to involve young citizens and students in mitigating the Global warming problem, Marine debris problem, Plastic Pollution Problem, implementing Circular Economy, UN SDG'S and this cooperation and collaboration will create model for other schools and colleges to follow and implement;

Recognizing that this collaboration to work at the ground level is of paramount importance to mitigate global warming and implement circular economy:

It is hereby agreed as follows:

Purpose

1. The purpose of this agreement is to establish a working framework for implementation of the following ground activities including but not limited to:
 - a. Cleaning beaches;
 - b. Cleaning mangroves;
 - c. Running ground action programs with citizens living in human - ocean conflict zones to –
 - i. To stop littering;
 - ii. To train people to shift away from a linear economy to a circular economy;
 - iii. Training communities to implement Extended Producer's Responsibility (EPR) activities with the partnership of small - scale plastic producers and citizens;
 - iv. To turn ocean plastic into recyclable raw material
 - v. Community development – cleaning toilets, food for plastic etc.
 - d. Ocean Clean-up - Cleaning creeks and Intertidal zones, inaccessible mangrove patches submerged under water during high tide with the help of boats.
 - e. River Mithi Rejuvenation – cleaning of the river and training people living on the banks of the river to not to litter and adopt Circular Economy.
 - f. Running Circular Economy programmes in 43 Padas-villages in a protected forest-Sanjay Gandhi National Park -
 - g. Running Circular Economy programs – Facilitating bulk purchase of vegetables, groceries and various other household items, etc without single use plastic.
 - h. Hosting seminars and conversations to protect and preserve Mother Nature.
 - i. Running Circular Economy and waste management programs in the institute.
 - j. Setting up of sustainability center in the institute.
 - k. Running Project Femme Freedom in the institute.
 - l. Participation of Students in Legal Aid and Governance Model:
 - Students will study various government scheme and help in implement the govt scheme at the ground level to help women, needy etc.
 - Students will also help in providing legal aid to the needy and poor.



- m. Two students will have the opportunity to join the Afroz Shah Foundation for a six-month internship. The internship periods will be from 1st August 2023 to 31st January 2024 and from 1st February 2024 to 31st June 2024.
 - n. Students will receive certificates upon completing a specific number of hours of participation during the academic year.
2. The parties do not intend that this MOU to create any specific legal binding obligations.

Scope

3. The parties shall conduct the activities as listed out at clause number 1 above with a mutual consent and satisfaction of both parties.
4. The parties shall develop and conduct these activities utilizing their expertise and facilities appropriate to specific tasks directed at achieving mutually agreed upon objectives, goals and outcomes.
5. The collaborative activities under this MOU will be conducted under areas contributed to improving environmental degradation where such cooperation contributes to the success of the activity. The activities may include: planning of the activities, information and knowledge sharing of the activities, monitoring of the activities, training for the activities, pollution prevention and remediation related to global warming, plastic pollution and circular economy or other such matters as the parties may agree upon based on mutual discussion and mutual consent.
6. The form of the cooperation under this MOU may consist of the following:
 - a. Joint participation in Clean-up activities - beach, ocean and mangroves.
 - b. Joint participation in Waste management and Circular economy program being run in Mumbai outside the college premises.
 - c. Joint participation in Waste management and Circular economy program inside the college.
 - d. Joint participation in Hosting seminars and conversations to protect and preserve Mother Nature.
 - e. Or any other forms of participation as the parties may agree upon.

Management

7. Activities undertaken under this MOU will be undertaken based on mutual consultation and consent.
8. The parties agree to designate a coordinator for implementing this MOU. The coordinators will meet once in three months to discuss and evaluate the activities undertaken under the MOU or to review any other matter concerning the MOU such as programme direction, etc.

Renewal, Amendment and Termination

9. This MOU shall remain in force for a period of five years from the date of the last signature. This MOU may be extended by the written consent of the parties.
10. This MOU may be terminated by either party giving written notice to the other party at least 180 days in advance of the stated termination date.



11. This MOU may be amended only by the written consent of the written consent of the parties. In witness thereof, the parties have offered their signatures hereto:



Memorandum of Understanding (MOU) for Faculty Exchange

This Memorandum of Understanding (MOU) is entered into on 15th July, 2022 between **Children Welfare Centre's College of Law**, located at Valnai Village, Marve Road, Orlem Bavadi Stop, Malad (West) Mumbai: 400064, hereinafter referred to as "**Party A**," and **Thakur Ramnarayan College of Law**, located at Thakur Ramnarayan Educational Campus, S.V. Road, Dahisar (East), Mumbai: 400068, hereinafter referred to as "**Party B**".

Preamble: Recognizing the importance of international academic collaboration and the benefits of faculty exchange in promoting academic and cultural understanding between our institutions, Party A and Party B hereby agree to establish a faculty exchange program based on the following terms and conditions.

Article 1: Purpose The purpose of this MOU is to promote academic collaboration, research cooperation, and faculty development between Children Welfare Centre's College of Law and Thakur Ramnarayan College of Law.

Article 2: Faculty Exchange Program.

1. Both parties agree to establish a faculty exchange program that will enable the exchange of teaching and research staff between their respective institutions.
2. Faculty members eligible for the exchange program shall be selected based on their academic qualifications, research expertise, and willingness to participate in the exchange.

Article 3: Duration of Exchange The duration of faculty exchange visits shall be determined for a period of five years. Exchange periods can vary from one semester to three academic year, subject to mutual agreement between the parties involved.

Article 4: Financial Provisions

1. Neither Party A nor Party B shall charge faculty exchange fees to the visiting faculty members during their exchange period.

Article 5: Responsibilities of the Sending Institution (Party A)

1. Party A shall nominate eligible faculty members for participation in the exchange program in consultation with Party B.
2. Party A shall ensure that selected faculty members have the necessary documents, including visas and work permits, for their exchange period at Party B's institution.

Article 6: Responsibilities of the Host Institution (Party B)

1. Party B shall provide visiting faculty members with suitable working facilities, resources, and support needed to conduct their teaching and research activities during the exchange period.
2. Party B shall appoint a designated contact person to assist visiting faculty members and facilitate their integration into the academic and social life at Party B's institution.

Article 7: Reporting and Evaluation

1. Both parties agree to regularly review and evaluate the effectiveness of the faculty exchange program and make necessary improvements.

2. Each party shall provide a comprehensive report on the exchange program, including the outcomes and achievements of the participating faculty members, at the end of each academic year.

Article 8: Intellectual Property Rights

1. Any intellectual property rights arising from joint research and collaborative activities shall be governed by a separate agreement between the involved parties.
2. Both parties shall respect and protect the intellectual property rights of the visiting faculty members during their exchange period.

Article 9: Termination Either party may terminate this MOU by providing written notice to the other party at least one month prior to the intended termination date.


Article 10: Amendments Any amendments to this MOU shall be made in writing and require the mutual consent of both parties.

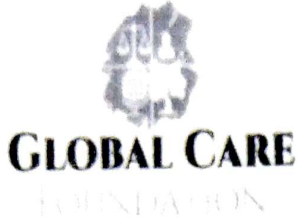

Proposed Activities



Legal Literacy/Awareness Camps: GCF, in collaboration with TRCL will organize Legal Literacy / Awareness Camps inside or outside the TRCL premises, public places, slum areas, etc. These Literacy Camps will aim to provide the students functional experience of legal awareness activities; they will contribute towards enhancing their communication skills and building their confidence. They will also provide them an excellent opportunity to acquaint themselves with grass-root level social work.

Socio-Legal Awareness Trainings/Lectures for students: GCF, with the help of experts from various fields, will design, develop and impart regular Socio-Legal Awareness Trainings/Lectures to the students which will complement and enhance their knowledge.



So, in all, it was an experience enriching program!



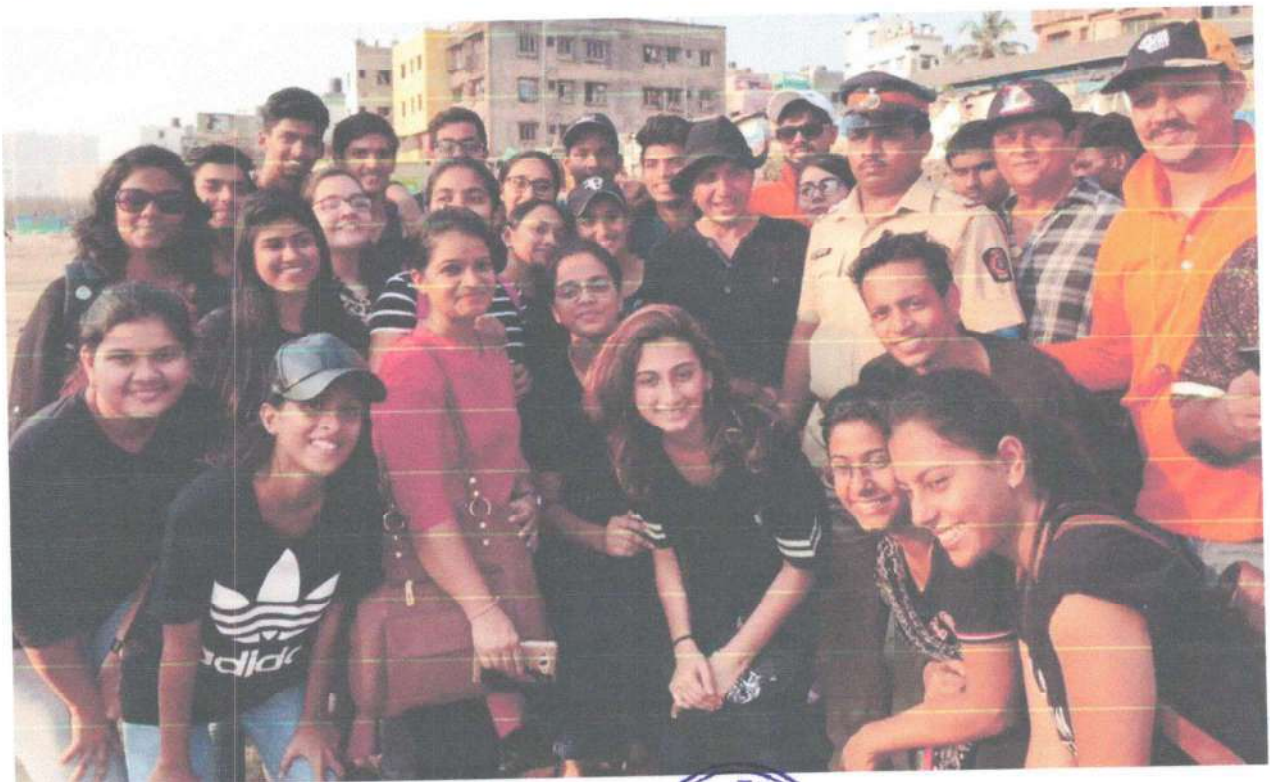


platform for individuals to understand their rights and learn about legal mechanisms available for addressing environmental concerns.

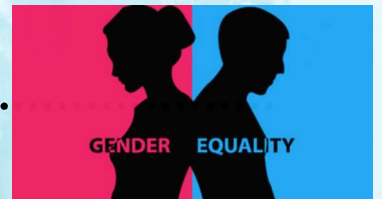

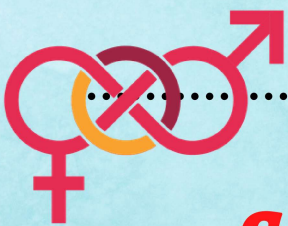


