### Admission Process and Commencement of Lectures



## Progress Review of the College from July 2019 to January 2021

### **Admission Process**

Thakur Educational Trust has been granted permission by Government of Maharashtra, University of Mumbai and Bar Council of India to start Three Years LL. B., Five Years LL. B. with intake capacity of 120 students in each course and LL.M. course with intake capacity of 60 students.

Admission process for LL.M. started from 19<sup>th</sup> August 2019 to 29<sup>th</sup> September 2019, B. L. S. /LL. B. started from 14<sup>th</sup> August 2019 and continued till 07<sup>th</sup> November 2019, whereas Three Years LL. B. from 13<sup>th</sup> September 2019 to 25<sup>th</sup> November 2019. Admission for the academic year 2019-20 was delayed due to the Common Entrance Test Cell.


Admission process for LL.M. started from 25<sup>th</sup> December 2020 to 01<sup>th</sup> January 2021, B. L. S. /LL. B. and Three Years LL. B. admission process will start from 08<sup>th</sup> February and 04<sup>th</sup> February 2021, respectively. Admission for the academic year 2020-21 is delayed due to a third-party audit from the Common Entrance Test Cell.

Induction programme for First Year B.L.S/LL.B was conducted from 17th September 2019 to 21st September 2019,, the college organised a one week induction program for the students introducing them to the various committees and their functioning. Each day was kept specifically for one committee each. The teacher co-coordinator and the student members explained the functioning of the respective committees through ppts. This presentation was followed by a doubt clearing session of the students by the members encouraging them to participate and take initiative in working for the committees. The teacher heads of the committees organised a demo training for the events held under every committee's right from demo moot court, Demo Asian parliamentary debate, police station visit and cultural events respectively.

#### **Guest Lectures:**

- Adv. Juzer Udaipuri (an independent lawyer, practicing in various fields of law including divorce, default or fraud, criminal defence, general legal and property law and has graduated as a solicitor of the supreme court of England & wales) addressed the students on the topic "Drafting, Pleading and Conveyancing" on 8th August 2019.
- 2. Adv. Puneet Chaturvedi addressed the students on the topic "Civil Procedure Code" on 9th November 2019. Adv. Puneet Chaturvedi took the students through the Civil

Procedure Code, 1908 covered all the relevant sections of the CPC from section 12, section 158 covered all the orders contained under the CPC. Detailed explanation was given by Advocate Puneet Chaturvedi regarding all the sections and orders of Civil Procedure Code 1908.

3. Adv. Puneet Chaturvedi addressed the students on the topic "Criminal Procedure Code, 1973" on 23<sup>rd</sup> November 2019. Through this, Adv. Puneet Chaturvedi gave a brief about the procedure of Criminal Proceedings and covered all the vital sections. It gave a detailed understanding of the important chapters of CrPC (Chapter I – Chapter XXXVII). The lecturer discussed various vital sections & terms like Bailable, Non Bailable, Cognizable & Non – Cognizable, FIR (First Information Report), NC (Non-Cognizable Report), Charge sheet, etc

4. Adv. Farhana Shah addressed the students on the topic "Free Speech and Social Media" on 20 July 2019. Adv. Farhana Shah, started her lecture enlightening the students with the fundamental rights under the constitution of India. She emphasized on the right to freedom of speech and expressions with reasonable restrictions on it. The speaker also discussed the recent happenings in our country with respect to social media and youth. She guided the students to understand the impact of social media and fake news on the country.

5. Adv. Rashda Ainapore addressed the students on the topic "SEARCH OF CASE LAWS" on 27th July 2019. She briefly explained the difference between litigation and non-litigation ambits of law. The lecture further included the explanation of legal aid and its role and functions. Ms. Rashda tried illuminating the students about the branches of legal aid clinic in the college premises.

6. "MENTORSHIP PROGRAM OF PARA LEGAL VOLUNTEERS" was organised on 31 August 2019. It was a student development program to mentor the students for Paralegal training and legal aid awareness. The guest speakers of the event were Ms. Sujata Jagtap (Founder of the NGO-Prayas), Ms.Rashda Ainapore (Advocate) and Mr. Suhail Shariff (Advocate), Mumbai.

7. A guest session was conducted on the Right to Information Act 2005. The chief guest of the session was Mr. Shailesh Gandhi, who is an eminent right to information activist and is a former Information Commissioner with the Central Information Commission, New Delhi. The guest session was held in association with the Praja Foundation. The guest session started at 11:00 am on 16th January 2020 at the seminar hall and was attended by the principal of TRCL, faculties of TRCL and students of the college. The guest session commenced with a brief introductory speech presented by Mr. Nilesh Kadam from the Praja Foundation and was then followed by the session of Mr. Shailesh Gandhi.

8. Kunal Kumbat, Partner AZB Mumbai, addressed the students on the topic "THE GOAL" on 7th March, 2020. The session started with understanding the meaning of the term "brainstorming" along with an analysis of the different elements that are involved in the process of brainstorming. The main objectives behind the program held was to improve the level of commitment and dedication amongst students towards their professional goals and highlight the importance of having professional goals.






## **Extra-Curricular Activities:**


