MOOT COURT ACHIEVEMENTS

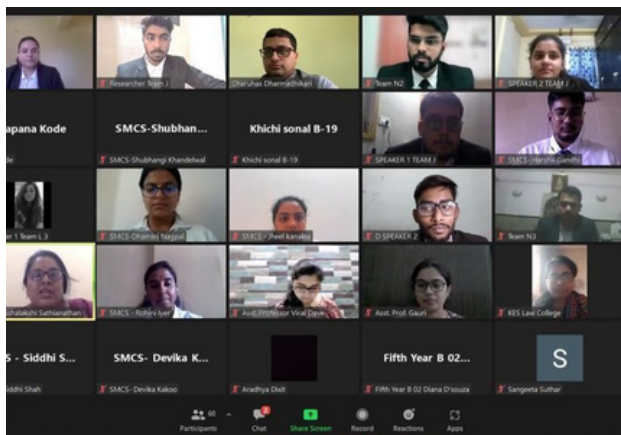
We also wish to congratulate all our students for their achievements in moot court activities.

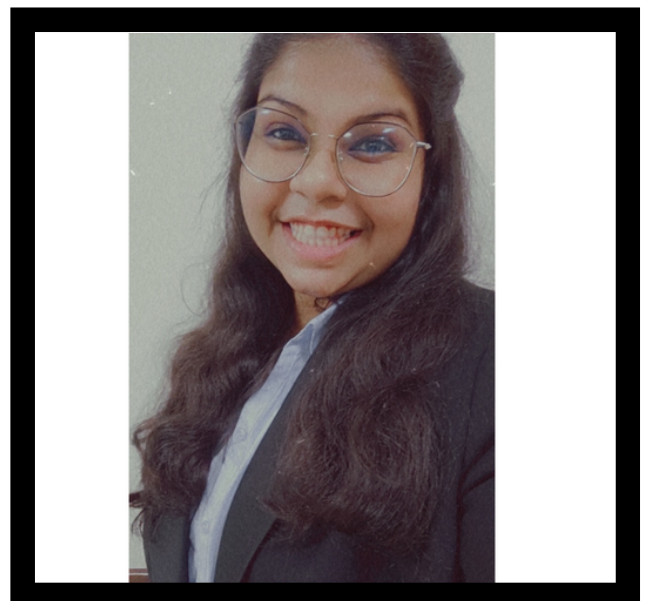

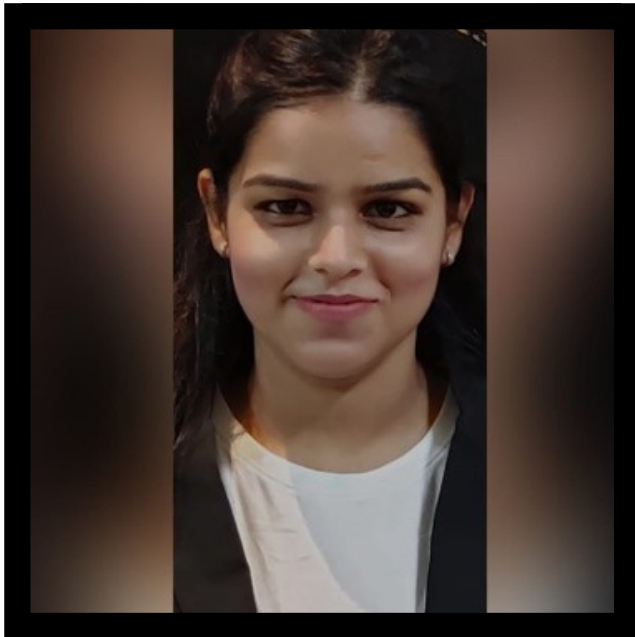
