FIRST YEAR LL.M. (2 YEARS COURSE) ADMISSION 2025-26

Candidates who appeared for the LL.M. Common Entrance Test 2025 conducted by the Department of Law, University of Mumbai and have passed LL.B. (3 Years Course) or B.L.S. LL.B. (5 Years Course) from the University of Mumbai or other recognized Universities are eligible to apply for LL.M. Admission 2025-26.

Admission will be given on a first-come-first-serve basis and can be secured from 22nd September 2025 to 4th October 2025 between 11 a.m. to 4 p.m. Candidates should apply at the earliest as seats are limited.

BUSINESS LAW (Group-II)— 60 seats CRIMINAL LAW (Group-V)— 60 seats

In order to seek admission, the minimum score in LL. M. Common Entrance Test-2025 conducted by Department of Law, University of Mumbai must be 40 marks (General Category) and 30 marks (Reserved Category).

Documents to be submitted at the time of Admission:

Self-attested photocopies (3 sets) of the following documents to be attached along with the hard copy of online Application Form at the time of confirmation of admission.

- 1) Extract of relevant page of LL.M. CET 2025 Scoresheet.
- 2) Photocopies of all semester marksheet / Mark Statement of LL.B. (3 Years) or B.L.S., LL.B. (5 Years Course) (Pass & Fail also) along with original for verification;
- 3) Std. XII (HSC or equivalent) marksheet for B.L.S., LL.B. (5 Years Course) candidates;
- 4) Graduation of all the years (All the Attempts) marksheet for LL.B. (3 Years Course) candidates and Degree Certificate (if available);
- 5) Those applying under Hindi Linguistic Minority category, leaving certificate stating mother tongue as Hindi or Affidavit/Declaration that the candidate belongs to Hindi Linguistic Minority;
- 6) Marriage Certificate or copy of Government Gazette (in case of name change);
- 7) Gap Certificate (if any);
- 8) Proof of Residence address like Aadhar Card / Passport / Telephone Bill (Landline) / Electricity Bill;
- 9) Two latest Passport Size photographs
