## **UNDISPUTED FACTS**

In the Republic of Zindia, the State of Zorashtra has recently witnessed a sudden surge in the illicit sale and distribution of a cough syrup branded “Ryzon” The city of Zumbai, particularly the Zandra area, reported multiple incidents of minors and young adults misusing the syrup for intoxicating purposes.

On the evening of 17<sup>th</sup> September, 2025, Police Constable Dev Patil, posted with the RTO Division of Zandra, reported an unusual pattern of movement near the bustling P-74, adjacent to Pillar No. 74 of the Zandra Station premises. He had observed an individual circling the area repeatedly, exchanging hurried glances and displaying behaviour that suggested they were either expecting someone or attempting to evade notice.

Acting on this intelligence, the Anti-Narcotics Team of Zandra swiftly mobilised and reached the location during peak transit hours. As the officers discreetly took positions, they spotted a man later identified as Rajesh standing near Pillar 74 with two white-coloured plastic bags.

The Anti-Narcotic team, as soon as they received this intel, reached the spot along with 2 Panchas. On interception, the officers discovered that these bags contained 1000 bottles of “Ryzon” cough syrup, each allegedly infused with Codeine Phosphate, a controlled narcotic substance prohibited except under lawful authorisation.

The officers conducted a search, during which they recovered bottles of Ryzon cough syrup from his possession. Upon further inquiry, the police inspected his mobile phone and discovered WhatsApp conversations that revealed active communication regarding the sale of the syrup. During the investigation, it was disclosed that Rajesh had been illicitly employed at a local pharmacy, through which the cough syrup was being distributed within the vicinity.

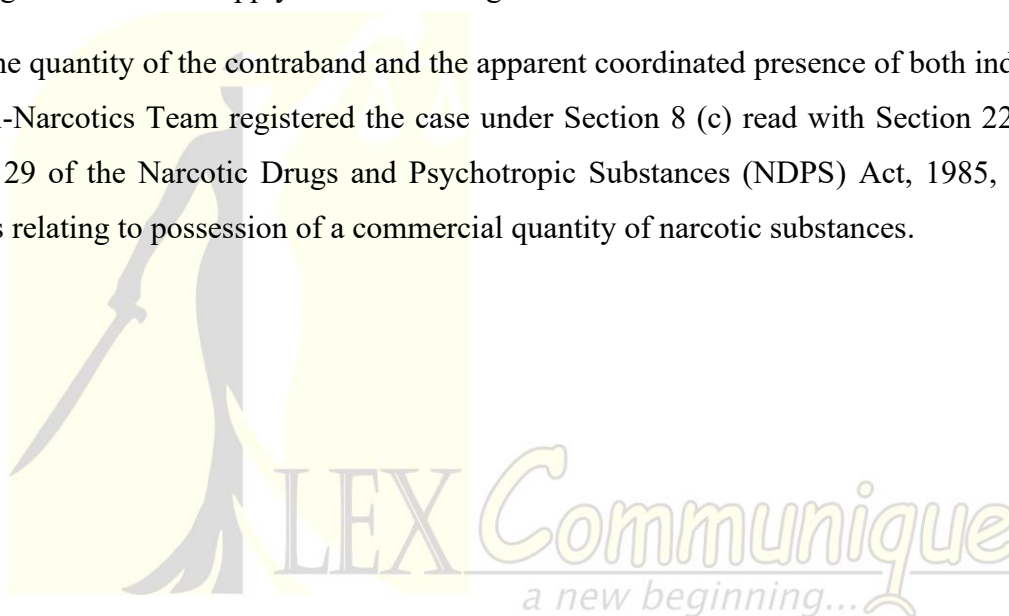
The investigation was subsequently widened. With the help of Call Detail Records (CDRs), the batch numbers printed on the seized bottles, and location data from Rajesh’s communications, the police traced the origin of the supply to a manufacturing outlet in Zaranasi, located in an industrial pocket on the outskirts of the city. Acting on the intelligence, a joint team of the NCB and local police conducted a raid at the premises, a two-storey warehouse disguised as a small-scale pharmaceutical packaging unit. The moment the officers entered, the gravity of the operation became evident.

Inside the warehouse, they discovered a substance that was illegally mixed into Ryzon cough syrup to enhance its intoxicating effect. Stacks of over 13460 filled bottles were found neatly

arranged in cartons, ready for dispatch to various parts of Zorashtra. Another section of the unit housed empty bottles, counterfeit labels, forged batch number stickers, and packaging material identical to that used by legitimate pharmaceutical manufacturers.

Amidst this large-scale illegal setup, the police found a young man known as “Kaju Bhai,” who appeared to be overseeing the packaging section. On checking his mobile phone and the documents on-site, it was revealed that multiple bank transactions linked to the illegal circulation had been routed through his personal account, and the medical shop used as the front for distribution was officially registered in his name. The conclusive documentary evidence, along with the seizure of huge quantities of adulterated cough syrup and scheduled narcotic substances, resulted in Kaju Bhai’s immediate arrest. He was taken into custody for his alleged role in operating a coordinated supply chain extending from Zaranasi to Zumbai.

Given the quantity of the contraband and the apparent coordinated presence of both individuals, the Anti-Narcotics Team registered the case under Section 8 (c) read with Section 22 (c), and Section 29 of the Narcotic Drugs and Psychotropic Substances (NDPS) Act, 1985, outlining offences relating to possession of a commercial quantity of narcotic substances.

## **12. Brief Course of the Investigation:**

Police Constable Dev Patil of the RTO Division, Zandra, reported suspicious activity near the crowded P-74 area beside Pillar No. 74 at Zandra Station. He noticed a man repeatedly circling the spot, glancing around nervously as if waiting for someone or attempting to avoid detection. Acting upon this information, the Anti-Narcotics Team immediately proceeded to the location with two panch witnesses. During surveillance, the officers identified an individual, later named as Rajesh Mishra, standing near Pillar 74 carrying two white plastic bags. When intercepted, the team searched the bags. It recovered 1000 bottles of 'Ryzon' cough syrup, each containing Codeine Phosphate, a notified narcotic drug that cannot be possessed or distributed without lawful authority. Rajesh's mobile phone was examined on the spot, revealing WhatsApp chats which indicated active involvement in the illegal sale of the syrup. These chats further disclosed that one Rajesh had been employed at a nearby pharmacy and was using the medical shop as a means to circulate contraband in the locality. Based on these leads, the investigation was expanded. Contact Details, batch numbers printed on the seized bottles, and the location data extracted from Rajesh's communications helped trace the source of the supply to a manufacturing outlet in Zaranasi, situated in an industrial belt on the city's outskirts. A joint NCB-local police team raided the premises, which operated as a two-storey warehouse disguised as a small pharmaceutical packing unit. Inside, officers found substances being illegally blended into Ryzon syrup to increase its intoxicating effect, along with hundreds of filled bottles packed in cartons for statewide distribution. Another section contained empty bottles, fake labels, forged batch stickers, and packaging material identical to that of legitimate manufacturers. At the site, police apprehended a man known as "Kaju Bhai," who appeared to be supervising the packing operations. Examination of his mobile phone and documents recovered from the warehouse revealed that several bank transactions linked to the illicit supply chain were routed through his personal account, and that the medical shop used as the distribution front was registered in his name. The voluminous seizure of adulterated cough syrup, narcotic substances, and incriminating documents led to his immediate arrest for orchestrating the supply chain extending from Zaranasi to Zumbai. Considering the commercial quantity of contraband, the involvement of multiple individuals, and the organised manner of the operation, the Anti-Narcotics Team registered offences under Section 8 (c) read with

Section 22 (c) and Section 29 of the NDPS Act, 1985, for unlawful possession, distribution of narcotic drugs.

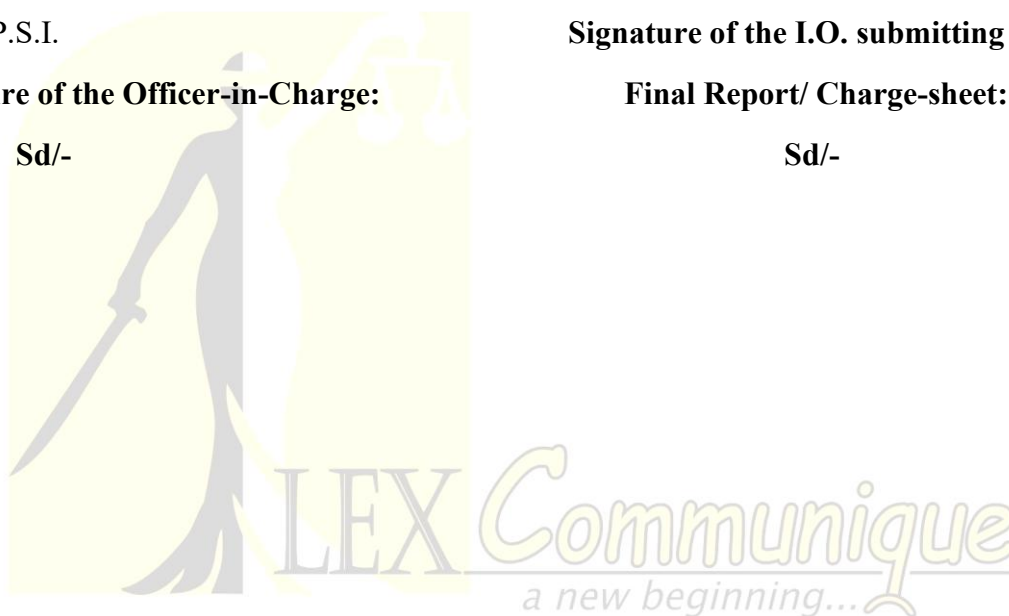

1000 bottles of 'Ryzon' cough syrup containing Codeine Phosphate were seized from the possession of the accused at Pillar No. 74, Zandra Station area.

**10. F.I.R. Contents (Attach separate sheets, if required):**

I, Police Constable Dev Patil, aged 47 years, by occupation Police Constable, attached to the RTO Division, Zandra, state that on the date of the incident, I reported for duty in my usual course.

At about the evening hours, while I was present near Pillar No. 74 of the Zandra Station premises, I noticed a male person roaming suspiciously, carrying two white plastic bags in his hands. He was repeatedly moving around the same place and looking here and there as if waiting for someone, which raised suspicion in my mind.

Considering the suspicious conduct of the said person, I immediately passed on this information to the Anti-Narcotics Team, Zandra, through official communication.

After some time, the Anti-Narcotics Team arrived at the spot along with two independent panch witnesses. In their presence, the said suspicious person was intercepted. On inquiry, he disclosed his name as Rajesh Mishra.

Thereafter, in my presence and in the presence of the panch witnesses, the two white plastic bags carried by the said person were checked. Upon checking, it was found that the said bags contained 1000 bottles of "Ryzon" cough syrup. On preliminary verification, the said bottles were suspected to contain Codeine Phosphate, which is a prohibited narcotic substance. The said person failed to produce any valid licence or authority for possession of the same. And informed that these products were received from Zaranasi Outlet.

Accordingly, the Anti-Narcotics Team seized the said bottles under the due seizure Panchnama, and the accused Rajesh was taken into custody.

Since the said act disclosed the commission of a cognizable offence under the Narcotic Drugs and Psychotropic Substances Act, 1985, I am giving this information for the purpose of registering an offence and taking necessary legal action.

**12. Action taken:** Since the above report of offence was registered under the NDPS Act, the accused was arrested, the property was seized, and the investigation was handed over to the Anti-Narcotics Team, Zandra.

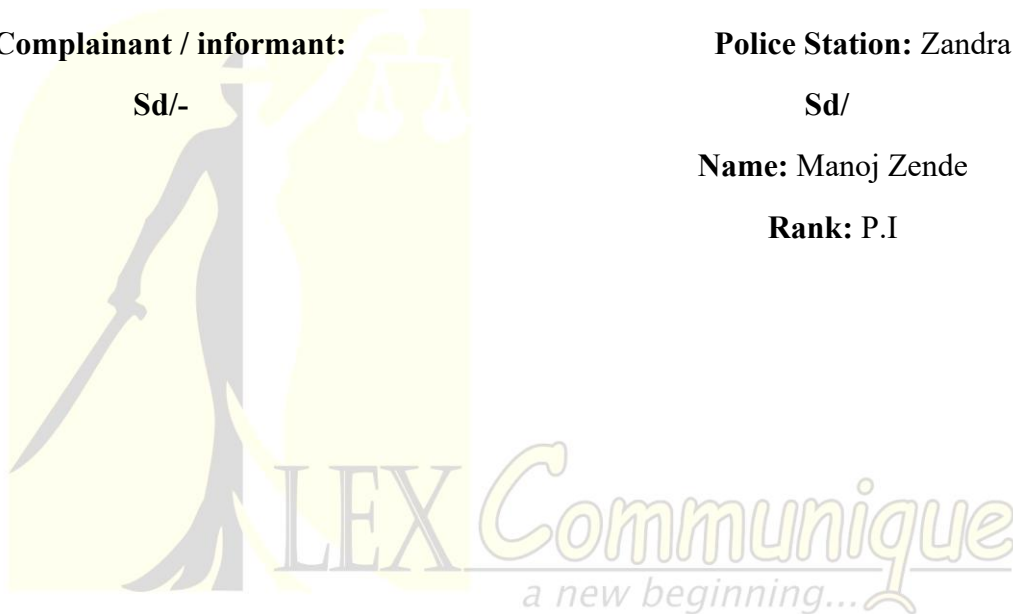



#### **1) Presence of Officers and Panch Witnesses:**

On the above date and time, a joint team of the NCB and Zandra Police conducted a search based on reliable information about the illegal possession and movement of Ryzon cough syrup, which contains a scheduled narcotic substance, by a Young Boy.

Two independent panch witnesses from the locality were called to be present during the search. They agreed to assist voluntarily.

#### **2) Names of Panch Witnesses:**

1) Neelu Bhatt, Occupation – Tea Stall owner.

2) Sunil Yadav, Occupation – Dairy Farming.

#### **3) Description of the Person/Premises Searched:**

Police Constable Dev Patil, posted with the RTO Division of Zandra, reported an unusual pattern of movement near the bustling P-74. He had observed an 18-year-old boy named Rajesh with two white bags, who appeared nervous, and also, at that place, many illicit drug distribution cases were registered. On his suspicious behaviour, the officers informed the Anti-Narco Team and seized his bag in accordance with Section 42 of the NDPS Act, 1985, and Section 103 of the BNSS.

#### **4) Conduct of Search:**

The officers informed the boy and the Panch witnesses about the purpose of the search. The search was carried out properly and in the presence of both panch witnesses.

*\*Articles Found and Seized*

**5) During the search, the following items were recovered:**

1. Two bags (1000 Bottles) of Ryzon cough syrup were found on Rajesh, suspected of containing narcotic substances.

I, Rajesh Mishra, aged 18 years, residing at P-30, Zandra, Zumbai, state as follows:

I have been falsely implicated in this case, and I did not know that the two bags I was carrying contained illegal substances. The bags were handed to me shortly before the incident by a transporter who told me they were ordinary medical items to be delivered to a nearby medical shop. Being only 18 years old and working occasionally as a helper for small errands, I neither opened the bags nor had any reason to doubt what I was told. I am not involved in the procurement, storage, stocking, or selling of any medicines, nor have I ever been engaged in any illegal activity.

When the police stopped me suddenly, I got frightened due to my age and lack of understanding of legal procedures. I was not aware of what was happening or why I was being questioned. The officers later showed me WhatsApp messages taken from my phone, but many of those chats are from groups or conversations I did not initiate. Some messages were from people who used my phone or sent forwarded content, and they have nothing to do with selling any cough syrup. None of those chats proves that I was aware of any illegal substance or that I was knowingly involved in any narcotics activity.

I also state that I have no financial connection, no bank transactions, and no link whatsoever with the alleged warehouse in Zaranasi. I have never travelled there, never contacted anyone from there, and have no role in any such operation. I come from a simple background, live with my family, and earn a small amount by doing occasional delivery tasks.

I had only been handed two sealed bags for delivery and was unaware of their contents. I had no intention to commit any offence, and there is no evidence that I had any conscious possession

or knowledge of narcotic substances. I believe I have been wrongly accused due to misunderstanding, assumptions made by the police, and because of my young age and inability to defend myself properly at the spot.

I state that I am innocent and have been needlessly dragged into this case despite having no role in the alleged offence.



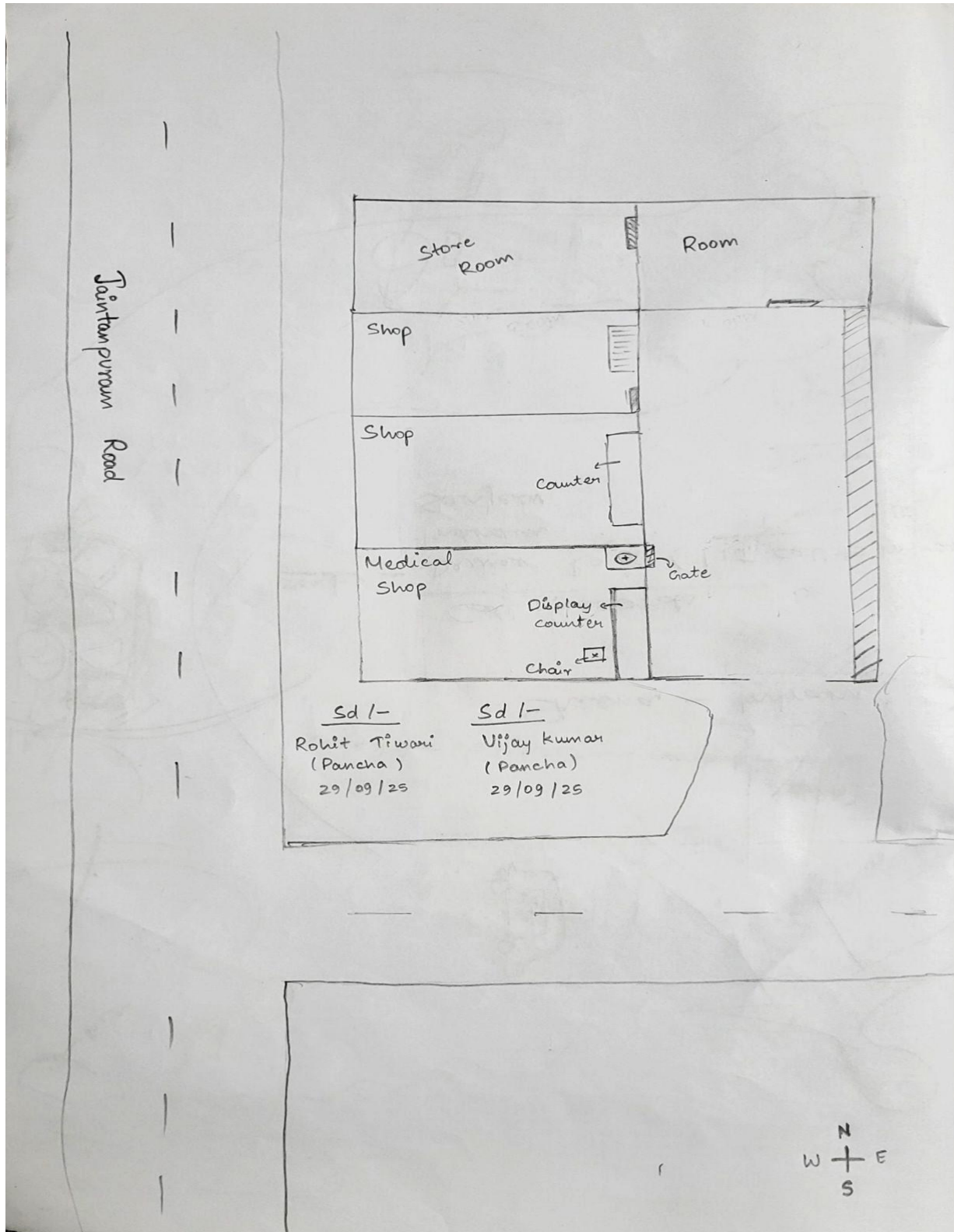

I don't know about the illegal trade and distribution of "Ryzon" brand cough syrup, which contains Codeine Phosphate, a controlled narcotic substance. My Malik is the proprietor of "Max View Pharma," which he used as a front for this illegal activity. I don't know about anything, the sourcing, adulteration, packing, and sale of the illicit cough syrup. The manufacturing and packing were conducted at a unit located in Zaranasi, which was established as a small-scale pharmaceutical packaging unit. At this location, I work as a medical shopkeeper, for which I earn 6,000 rupees per month. I don't know about mixing controlled substances into the cough syrup to enhance its intoxicating effect. I don't know that they are counterfeiting labels, forged batch number stickers, and packaging materials, as I am illiterate; everything seems legitimate to me. My role involved managing the medical shop, which was located in Jaitanpuram, Zaranasi. The medical shop used for distribution was registered in my Malik's name. On 29<sup>th</sup> September 2025, I was apprehended by the police team from the Anti-Narcotics Cell, Zumbai, at the medical shop address in Jaitanpuram. I confess that I was not involved in the sale and distribution of a commercial quantity of Codeine Phosphate mixed in cough syrup authorisation. I have heard the above statement read over to me, and it has been explained to me.

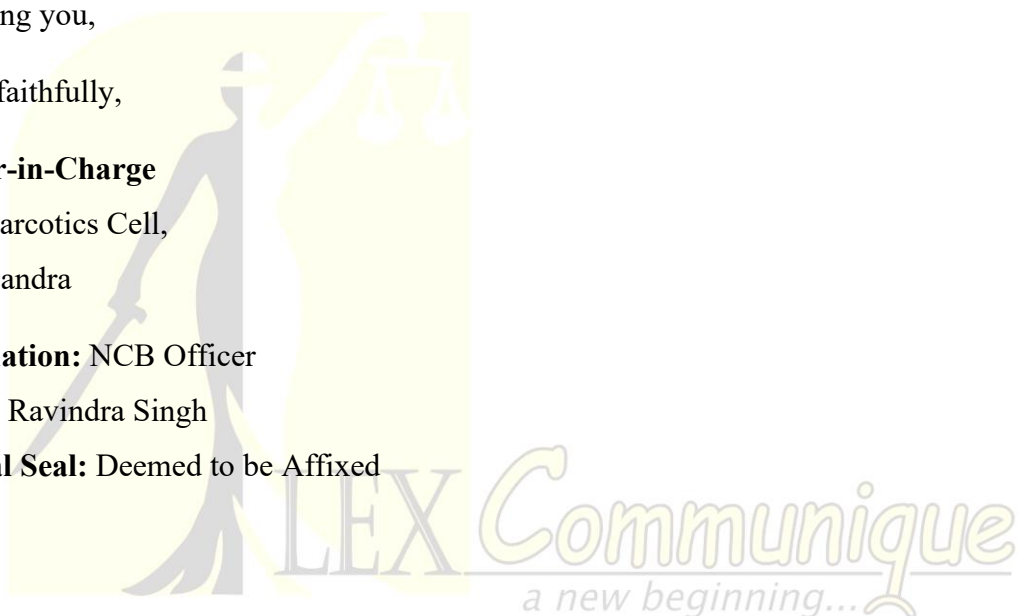

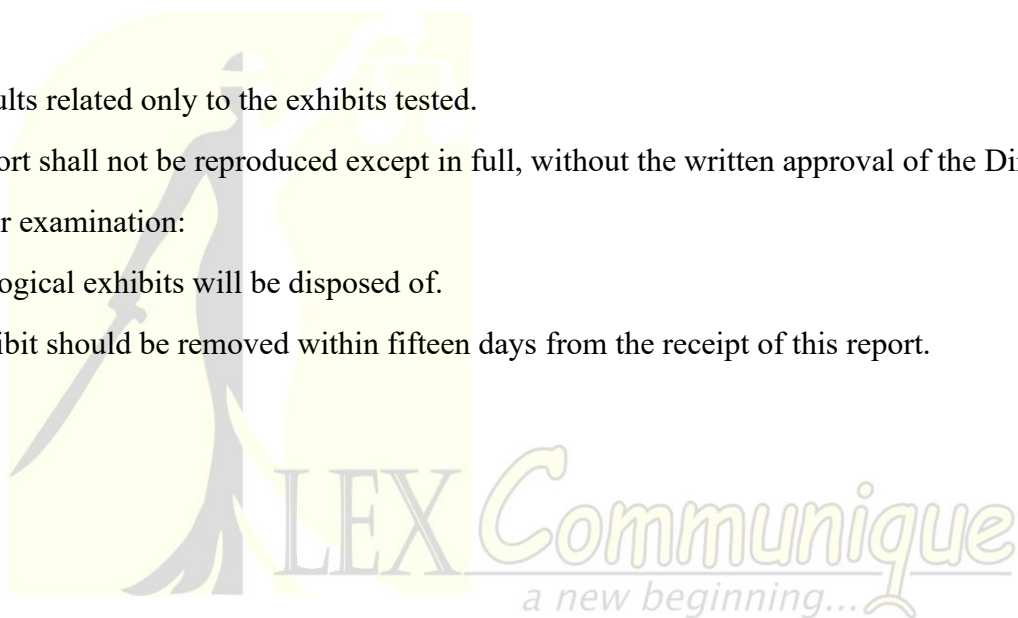

We, the above-mentioned Panchas, state that we were called by the Police Inspector (P.I.) Manoj Zende of the Anti-Narcotics Cell, Zandra Unit, Zumbai, to the office of the Anti-Narcotics Cell. Upon our arrival, P.I. Zende introduced himself and his team members. He requested us to act as independent Panch witnesses for the proceedings of identifying and certifying the inventory of seized narcotic substances in C.R. No. 017/2025. We agreed to do so. He informed us that Police Constable Dev Patil of the RTO Division, Zandra, had reported suspicious activity near the crowded P-74 area beside Pillar No. 74 at Zandra Station. Acting on this intelligence, the Anti-Narcotics Team conducted surveillance and intercepted an individual named Rajesh Mishra. Upon searching him, they recovered 1000 bottles of 'RYZON' cough syrup containing Codeine Phosphate, a notified narcotic drug.

P.I. Zende further explained that the investigation revealed a larger conspiracy. The probe led to a pharmacy employee named Rajesh and traced the source to a manufacturing outlet in Zaranasi. A subsequent raid at this warehouse led to the seizure of a commercial quantity of 13,460 bottles of adulterated Ryzon syrup and the arrest of the mastermind, Kaju Khatri alias Kaju Bhai.

He stated that the seized property (Muddemal), consisting of Cough Syrup Bottles, is currently in police custody. As per the mandate of Section 52A of the NDPS Act, this property must be produced before a Magistrate for:

1. Certification of the inventory.
2. Taking photographs.
3. Drawing of representative samples in the presence of the Magistrate.

We, the Panchas, along with P.I. Manoj Zende, Police Writer Vedant, Photographer Shri. R. Dayma and the Muddemal Clerk Sahil Talwar (who carried the seized property) proceeded from the Anti-Narcotics Cell office to the Hon'ble Magistrate's Court.

We appeared before Hon'ble Magistrate Shri. D. Mondal, presiding over Court No. 64, Zumbai.

The Investigating Officer produced the seized property, which consisted of a total of Twenty-Four (24) Brown Cartons taken from the safe custody of the Police Malkhana

The Hon'ble Magistrate personally examined the first bag labelled "Exhibit Batch H". The Hon'ble Magistrate verified that the bag was properly stitched and sealed with the official lac seal of the Anti-Narcotics Cell, and the seals were intact and untampered.

Upon the order of the Hon'ble Court, the seal was broken, and the mouth of the gunny bag was opened in our presence. Inside, a cardboard carton was found. Upon opening the carton, it was found to contain cough syrup bottles.

- i. **Description:** The bottles bore the label "RYZON COUGH SYRUP 100 ml". The label indicated the composition included Codeine Phosphate.
- ii. **Count:** In our presence, the court staff counted the bottles. There were exactly 14,460 bottles in this batch.
- iii. **Weighing:** The bottles were placed on an electronic weighing scale.
  - a. **Gross Weight:** 1,446,000,000 grams.
  - b. **Net Weight:** 1,446,000,000 grams.

### Drawing of Samples:

1. **Reserve Sample (H-1):** Under the direction of the Hon'ble Magistrate, **01 bottle** was randomly selected from the lot as a representative reserve sample. This bottle was placed inside a new light green paper envelope. The envelope was pasted with a slip signed by us (Panchas), P.I. Zende, and the Hon'ble Magistrate. It was tied with a white thread and sealed with lac seals of the Hon'ble Court. This packet was marked as Exhibit 'H-1' (Reserve Sample).
2. **C.A. Sample (H-2):** Then, another 01 bottle was randomly selected as a sample for Chemical Analysis. It was placed inside a new light green paper envelope. The envelope was pasted with a slip signed by the Magistrate and us. It was tied with a white thread and sealed with lac seals of the Hon'ble Court. This packet was marked as Exhibit 'H-2' (C.A. Sample).

### Packing of Remaining Property:

The remaining 250 bottles of Batch H were placed back into their original cardboard box. The box was taped shut. This box was then placed into a gunny bag. The mouth of the bag was folded and stitched closed using a needle and twine. A paper label signed by us and the Magistrate was affixed. The bag was sealed with lac seals of the Hon'ble Court. This sealed bag was marked as Exhibit 'Batch H' (Remaining).

*(The original empty gunny bag of Batch H was kept aside for separate packing).*

The Hon'ble Magistrate then examined the second bag labelled "Exhibit Batch I". The Hon'ble Magistrate verified that the seals were intact and untampered.

Upon the order of the Hon'ble Court, the bag was opened. Inside, a cardboard carton was found containing cough syrup bottles.

1. **Description:** The bottles bore the label "RYZON COUGH SYRUP 100 ml" containing Codeine Phosphate.
2. **Count:** We counted the bottles. There were exactly 250 bottles in this batch.
3. **Weighing:**
  - a. **Gross Weight:** 25000 grams.
  - b. **Net Weight:** 25000 grams.



### **Drawing of Samples:**

1. **Reserve Sample (I-2): 01 bottle** was randomly selected as a representative reserve sample. It was placed inside a new light green paper envelope, signed by us and the Magistrate, tied with white thread, and sealed with lac seals of the Hon'ble Court. This packet was marked as **Exhibit 'I-2' (Representative Reserve Sample)**.
2. **C.A. Sample (I-1):** Then, another **01 bottle** was randomly selected as a sample for Chemical Analysis. It was placed inside a new light green paper envelope, signed, tied, and sealed with lac seals of the Hon'ble Court. This packet was marked as **Exhibit 'I-1' (C.A. Sample)**.

### **Packing of Remaining Property:**

The remaining 250 bottles of Batch I were placed back into their original cardboard box. The box was taped shut and placed into a NEW white plastic gunny bag. The bag was stitched closed, labelled, and sealed with lac seals of the Hon'ble Court. This sealed bag was marked as Exhibit 'Batch I' (Remaining).

*(The original empty gunny bag of Batch I was kept aside for separate packing).*

**Hon'ble Magistrate** then examined the third bag labelled "**Exhibit Batch J**". The seals were verified to be intact. Upon the order of the Hon'ble Court, the bag was opened. Inside, a cardboard carton was found containing cough syrup bottles.

1. **Description:** The bottles bore the label "RYZON COUGH SYRUP 100 ml" containing Codeine Phosphate.
2. **Count:** We counted the bottles. There were exactly 250 bottles in this batch.

**Packing of Remaining Property:**

The remaining 250 bottles of Batch J were placed back into their original cardboard box. The box was taped and placed into a NEW white plastic gunny bag. The bag was stitched, labelled, and sealed with the Court's seal. This sealed bag was marked as Exhibit 'Batch J' (Remaining).

*(The original empty gunny bag of Batch J was kept aside.)*

Hon'ble Magistrate then examined the fourth bag labelled "**Exhibit Batch K**". The seals were verified to be intact.

Upon the order of the Hon'ble Court, the bag was opened. Inside, a cardboard carton was found containing cough syrup bottles.

1. **Description:** The bottles bore the label "RYZON COUGH SYRUP 100 ml" containing Codeine Phosphate.
2. **Count:** We counted the bottles. There were exactly 250 bottles in this batch.
3. **Weighing:**
  - A. **Gross Weight:** 25000 grams.
  - B. **Net Weight:** 25000 grams.

**Drawing of Samples:**

1. **Reserve Sample (K-1): 01 bottle** was randomly selected as a representative reserve sample. It was packed in a light green envelope, signed, tied, and sealed with the Court's seal. This packet was marked as Exhibit 'K-1' (Reserve Sample).
2. **C.A. Sample (K-2): 01 bottle** was randomly selected for Chemical Analysis. It was packed in a light green envelope, signed, tied, and sealed with the Court's seal. This packet was marked as Exhibit 'K-2' (C.A. Sample).

**Packing of Remaining Property:**

The remaining 250 bottles of Batch K were placed back into their original cardboard box. The box was taped and placed into a NEW white plastic gunny bag. The bag was stitched, labelled, and sealed with the Court's seal. This sealed bag was marked as Exhibit 'Batch K' (Remaining).

*(The original empty gunny bag of Batch K was kept aside.)*

Following the repacking of the bottles, the four (4) Original Empty White Plastic Bags (which originally contained Batches H, I, J, and K and bore the original police seals) were collected.

These four empty bags were folded and placed inside a single new white plastic gunny bag. The mouth of this new bag was folded inward and stitched closed using a needle and twine. A paper label signed by us, Pancha's, P.I. Zende, and the Hon'ble Magistrate was affixed to it.

The bag was then sealed with lac seals of the Hon'ble Court. This sealed bag was marked as Exhibit 'AA' (Original Packaging Material).

## **5. PHOTOGRAPHY AND CERTIFICATION**

Throughout the entire process described above, including the breaking of original seals, the counting of bottles, the weighing, the drawing of samples, and the affixing of new Court seals, photographs were taken by the official photographer, Shri. R. Dayma

The Hon'ble Magistrate verified the correctness of the inventory, the list of samples drawn, and the photographs taken in their presence.

## **6. COURT ORDER ON CUSTODY**

The Hon'ble Magistrate ordered that:

1. The **C.A. Samples** (Exhibits H-2, I-1, J-2, K-2) be handed over to P.I. Manoj Zende for immediate dispatch to the Forensic Science Laboratory (FSL) for analysis.
2. The **Representative Reserve Samples** (Exhibits H-1, I-2, J-1, K-1), the Remaining Property (Batches H, I, J, K Remaining), and the Packaging Material (Exhibit AA) be returned to the Anti-Narcotics Cell Malkhana for safe custody until further orders.

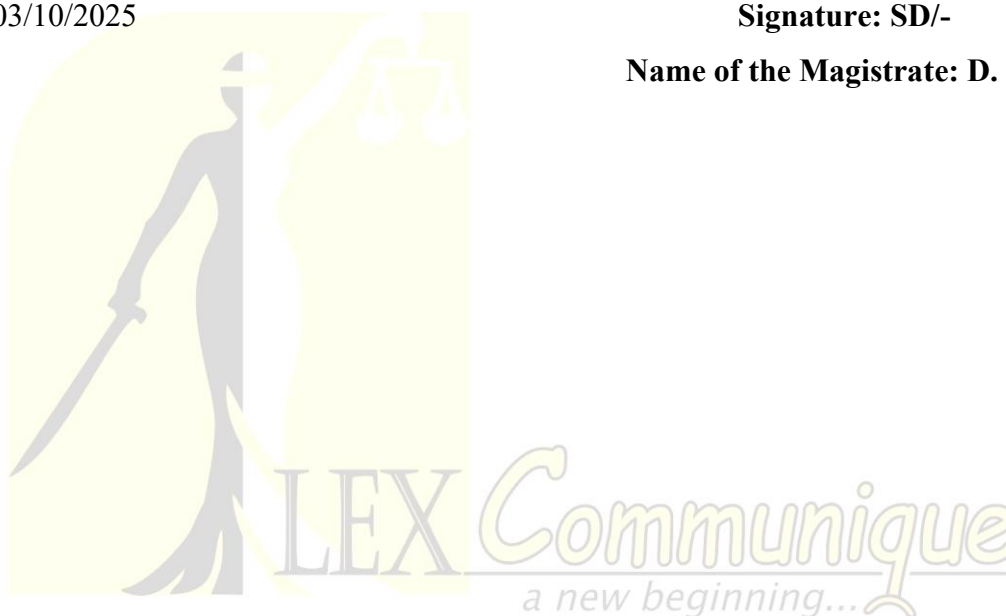

**APPLICATION FOR POLICE CUSTODY REMAND**

The Applicant–State respectfully submits:

1. That the accused Kaju Khatri was arrested on 29.09.2025 from a warehouse at Zaranasi, where a large-scale illegal packing and distribution unit of Ryzon cough syrup was detected.
2. That though the accused was found supervising packing activities, investigation so far reveals that he is not the ultimate kingpin, but a link in a larger organised syndicate.
3. That preliminary investigation suggests:
  - i. Presence of higher-level financiers,
  - ii. Involvement of additional manufacturers and suppliers,
  - iii. Routing of proceeds through multiple accounts and intermediaries.
4. That the accused has not yet disclosed:
  - i. Complete financial trail,
  - ii. Identity of persons supplying raw narcotic substances,
  - iii. Names of distributors operating in other districts.

5. That custodial interrogation is necessary to:
- i. Recover electronic devices and documents,
  - ii. Confront the accused with bank records and forensic reports,
  - iii. Identify the main accused and other conspirators under Section 29 NDPS Act.
6. That mere judicial custody will seriously hamper investigation, as the offence involves commercial quantity, organised crime, and inter-state ramifications.

### **PRAYER**

It is therefore most respectfully prayed that this Hon'ble Court may be pleased to:

Grant police custody remand of accused Kaju Khatri for 30 days, as there is reasonable suspicion of involvement of an unknown accused in the larger conspiracy, and further custodial interrogation is essential to identify and apprehend the said person(s).

**STATEMENT OF DEV PATIL**

**(PROSECUTION WITNESS-1)**

*(Under section 180 of BNSS)*

**Name:** Dev Patil

**Father's Name:** Amit Patil

**Address:** Zandra Police Station, Zumbai.

I, Dev Patil, aged 47 years, residing at Near Pillar No.1, Harizone Society, Zandra, Zumbai, Police Officer with the RTO Division, Zandra, state as follows:

On the evening of 17/09/2025, I was travelling through the P-74 area near Pillar No. 74, a route that is widely known in the locality for frequent drug-related activity and suspicious movement, when I noticed a man, later identified as Rajesh, repeatedly circling the same spot. He was constantly looking around, exchanging hurried glances with passersby, and behaving in a manner that suggested he was either waiting for someone or deliberately trying to avoid being noticed. His behaviour appeared highly unusual for that location and time, and because I was familiar with drug-related incidents on that stretch, I immediately sensed that something suspicious was taking place. I contacted the local police authorities and reported the matter, and the information was immediately relayed to the Anti-Narcotics Team of Zandra. Acting promptly on this intelligence, the Anti-Narcotics Team mobilised and reached the spot during peak transit hours. When they took discreet positions, they located the same individual I had described, standing near Pillar No. 74 and holding two white-coloured plastic bags.

The officers intercepted him in the presence of the Pancha witness. In my presence, they conducted a lawful search of the two plastic bags, which revealed 1000 bottles of "Ryzon" cough syrup, suspected to contain Codeine Phosphate, a controlled narcotic substance prohibited without valid authorisation. The bottles were counted and seized on the spot after proper sealing and documentation.

During further inquiry, the officers checked the accused's mobile phone, which contained WhatsApp conversations showing active communication about the sale of the Ryzon syrup. The chats further suggested that Rajesh had been illicitly employed at a nearby pharmacy, through which the distribution of the syrup was being carried out.

I confirm that I was the person who initially observed the suspicious behaviour and provided the information that led to the Anti-Narcotics Team's arrival. I witnessed the interception, the recovery of the bags, and the seizure of the contraband. The entire procedure was conducted lawfully, openly, and without any coercion or planting of material. I clearly identify Rajesh Mishra as the same person whose suspicious conduct I first observed on the P-74 road, which is known for narcotics activity. I make this statement voluntarily and truthfully.

I, Neelu Bhatt, son of Suresh Bhatt, aged 40 years, occupation Tea Stall Owner, residing at Bhatt Tea Corner beside Zandra Railway Station, Zandra, Zumbai, state as follows:

On 17/09/2025, while I was at my tea stall near Zandra Railway Station, the Anti- Narcotics Police Officials approached me and informed me that a suspicious person had been intercepted near Pillar No. 74. Since I was present in the vicinity and had earlier noticed the same person moving unusually and suspiciously, I agreed to act as a Pancha witness and accompanied the police team to the spot.

Upon reaching the location, I saw the accused Rajesh Mishra standing with two white plastic bags. In my presence, the police questioned him about the contents of the bags, but he could not provide any satisfactory explanation. The police officers then conducted a search of both bags on the spot, in accordance with the law, and I personally witnessed the entire process. When the bags were opened, I saw that they contained 1000 bottles of "Ryzon" cough syrup, which the officers informed me was suspected to contain Codeine Phosphate, a narcotic substance. I witnessed the police count each bottle and then mark and seal the seized material properly. I confirm that nothing was added to or removed from the bags during the search and sealing process. I also witnessed the seizure of the accused's mobile phone, which was placed in a separate sealed and labelled envelope in my presence. The accused was informed of the seizure at the spot. I confirm that the entire search and seizure procedure was conducted openly, lawfully, and without any coercion or planting of material. After the proceedings were completed, the Memorandum Panchnama was prepared at around 8:30 PM, and it was read over to me in a language I understood. After understanding its contents, I signed it as a Pancha witness. I make this statement voluntarily and truthfully.

I, Rohit Tiwari, son of Kamal Tiwari, aged 39 years, occupation Pandit, residing at near of Jaitanpuram Police Station, Zaranasi, Zuttar Pradesh, on 29/09/2025, while I was going for mandir a police officer named Gautam called and asked me to act of Pancha for the search and seizure operation in the present matter, and then I agreed to act as a Pancha witness and accompanied the police team to the spot. The location was described as a two-storey warehouse in an industrial pocket on the outskirts of Zaranasi. In the Natiimli area, Jaitanpuram, Zaranasi, Zuttar Pradesh, upon reaching the said premises, which appeared to be a residence of someone, and it also has a small medical Shop, the main door was opened, and we entered the premises. Inside that residence, a small-scale pharmaceutical packing unit was there. The police officials announced their identity and purpose. I witnessed the police officials conducting a thorough search in my presence.

During the search, the following items were discovered and seized: A large quantity of bottles of "Ryzon" brand cough syrup, already filled and sealed in 22 cartons, which contained a total number of 13,460 bottles ready for dispatch. A substantial stock of empty bottles, counterfeit labels, forged batch number stickers, and packaging material, including the machines for the filling and packing of the bottles. Various substances, powders, and liquids, which the officers stated were being illegally mixed into the cough syrup to enhance intoxicating effects. Documents and ledgers related to the operation. During the search, a young man was identified as Kaju Bhai. was found present at the location. He was apprehended by the police. The police officials checked his mobile phone and on-site documents in my presence. From these, it was revealed that the said premises and a medical shop named "Max-view Pharma" were linked to him, and financial transactions related to the sale of "Ryzon" bottles were routed through his accounts.

That the seized items were counted, listed, and packed in my presence. The police prepared a detailed seizure memo (Panchnama) on the spot, which I have signed after verifying that the contents recorded therein are true and correct to the best of my knowledge and observation. I was a witness to the entire search and seizure procedure from beginning to end. The allegedly accused Kaju Bhai was then formally arrested by the police officials after following due procedure. I confirm that I witnessed the arrest. I have read the contents of this statement, and they are true and correct.

On 03/10/2025, I received another pack of 22 sealed articles by the Narcotics unit of Zandra Police. The articles contained a total of 13460 bottles of Ryzon Cough Syrup. Upon initial inspection, I confirmed that all the seals on the submitted items were intact and matched the sample of Codeine provided by the police for verification. This statement is being recorded to aid in the ongoing investigation concerning the NDPS Special Case. I affirm that I will provide my testimony and any necessary statements during the trial, as and when required by the court.

I am presently working as the Malkhana In-charge at the Zandra Police Station and have been performing the said duties for the past several years. As part of my official responsibilities, I am required to receive, record, store, and produce seized articles in accordance with the prescribed procedure.

On the date relevant to the present case, the seized articles were deposited in the Malkhana during late evening hours. Due to heavy workload and shortage of staff, the formal entries in the Malkhana Register could only be completed on the following day. The seized property remained in the custody of the police station during this intervening period.

The storage facility of the Malkhana at Zandra Police Station is limited in capacity and does not have climate-controlled arrangements. The room is poorly ventilated and remains humid, particularly during the monsoon season. There have been occasions when water seepage from the ceiling has been noticed, and the condition of the storage area has been reported verbally to senior officers on more than one occasion.

I further state that the seized bottles and sample packets in this case were kept on a common storage rack along with other case properties, as no separate or sealed compartment was available. Due to space constraints, the seized articles were moved within the Malkhana more than once to accommodate additional property from other cases.

The samples intended for forwarding to the Forensic Science Laboratory were not dispatched immediately. There was a delay of a few days in sending the samples due to procedural formalities and lack of transport availability. During this period, the sealed packets remained stored in the same Malkhana facility.

I state that while the seals appeared intact at the time of dispatch, I am not in a position to certify the environmental conditions under which the seized articles were stored during the entire period, nor can I confirm that the seized property remained untouched at all times, as multiple officers have access to the Malkhana.

This statement is made to the best of my knowledge and based on official records maintained at the Malkhana.
