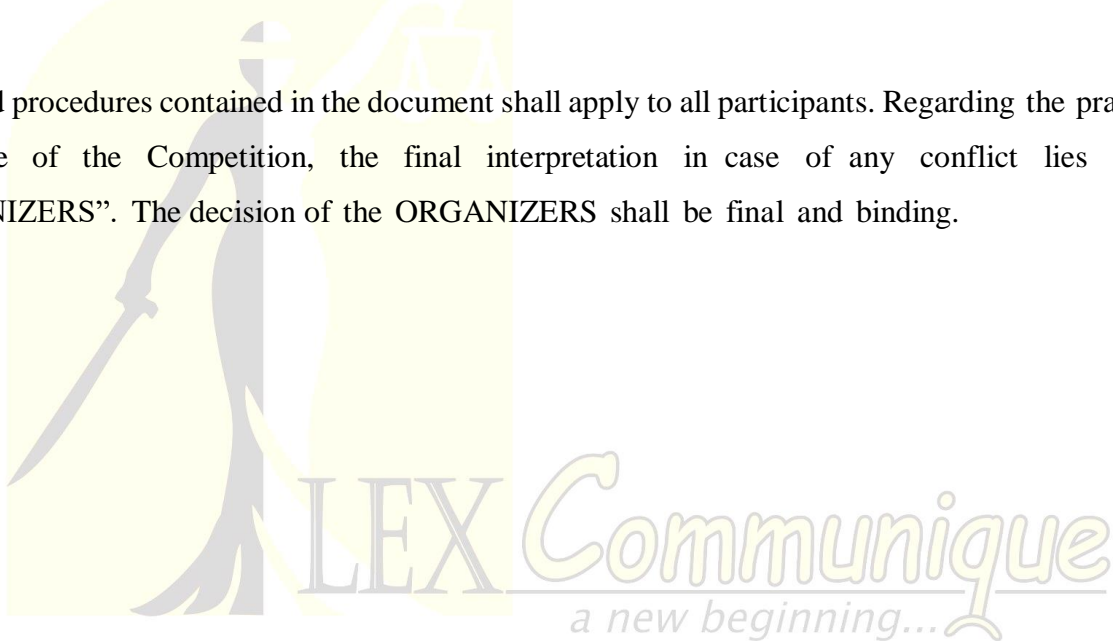

## **ABOUT POLICY PRESENTATION**

The “POLICY PRESENTATION” empowers participants by enhancing critical thinking, communication and analytical skills through the formulation and presentation of policies on assigned topics. Participants engage in rigorous research, allowing them to explore diverse perspectives and understand the complexities of policy-making. This hands-on approach not only provides practical experience in real-world policy-making but also develops confidence in public speaking and persuasive communication. By working on impactful policy solutions, participants cultivate a spirit of cooperation and leadership. This event serves as a crucial launchpad for aspiring leaders and innovators, equipping them to tackle pressing societal challenges and harness their potential to create meaningful, transformative change in the world.

## **IMPLEMENTATION AND INTERPRETATION OF THE RULES**

Rules and procedures contained in the document shall apply to all participants. Regarding the practice and procedure of the Competition, the final interpretation in case of any conflict lies with the “ORGANIZERS”. The decision of the ORGANIZERS shall be final and binding.



## **ELIGIBILITY**

1. Students pursuing their undergraduate course from any recognized college/ university are eligible to participate in the competition.
2. A minimum of one participant from each college can participate in this event.

## **DATE & VENUE**

The said competition will be held from 8th February 2025 at Thakur Ramnarayan College of Law, S.V. Road, Dahisar East, Mumbai – 400068.

## **REGISTRATION**

1. Each institution must, first, provisionally register itself for the Competition by sending an Official Provisional Registration mail to [lexcommunique@trcl.org.in](mailto:lexcommunique@trcl.org.in) by 15th January 2025.
2. Only upon the confirmation of the provisional registration by the organizers, the participants shall complete the further registration process by filling and uploading the following attached documents:
  - Registration form
  - Approval letter
  - Scanned ID Cards
  - Screenshot of the payment on the link. Link- <https://forms.gle/FpW2renBxXYYuxW57>

Participants will receive an acknowledgement/approval as a confirmation of their registration & participation periodically after registration.

## **REGISTRATION FEES**

1. The registration process has been divided into 2 slots:
  - Rs. 1200/- for Individual Participants (only for Participants residing in Mumbai)
  - Rs. 500/- for Participants who have already registered for Moot Court Association or Vidhi Chhatra Sansad
2. Registration will be based on first come first serve basis.
3. Total registration capacity = 15 Participants
4. The Registration fees shall be accepted through online transactions.

### **1. Word Count:**

The policy document should contain a minimum of 3500 words and a maximum of 5000 words.

### **2. Heading:**

Font Size: 14, Font: Times New Roman

### **3. Main Text:**

Font Size: 12, Font: Times New Roman, Line Spacing: 1.5, Alignment: Justified, Language: English

### **4. Footnotes:**

Font Size: 10, Font: Times New Roman, Line Spacing: Single, Citation Style: Chicago Style

## **PRESENTATION GUIDELINES**

### **1. Emphasize the Importance of the Issue:**

Start by explaining why the problem you're addressing matters. Make it relatable by highlighting how it affects people and the nation's future. Show why it's essential to tackle this issue if India is to thrive by 2047.

### **2. Clearly Present Your Policy Proposal:**

Lay out your proposed solution in a straightforward and logical way. Focus on the benefits it will bring and the practical steps for making it happen. Show how this policy can create positive changes that impact both society and the economy.

### **3. Show How the Policy Will Shape India's Future:**

Explain how your policy will help India emerge as a global leader by 2047. Connect the dots between your solution and how it will help India solve domestic challenges, gain international respect, and stand tall on the global stage.

#### **4. Make Use of Visuals:**

Use simple but impactful visual aids like charts, infographics, or slides to make your ideas clear and engaging. A picture or well-structured slide can go a long way in helping your audience understand the significance of your proposal.

### **RULES FOR POLICY PRESENTATION COMPETITION**

#### **1. Policy Submission:**

- i. The policy must be submitted in PDF format at least one month prior to the event.
- ii. The PowerPoint presentation (PPT) must be submitted one week prior to the event to the Lex Communique official E-mail ID.

#### **2. Time Frame:**

Each participant will be allotted 10 minutes in total:

- i. 5 minutes for the presentation
- ii. 5 minutes for the Q&A session

#### **3. Attire:**

Participants must wear Western or Indian formal attire during the competition

#### **4. Language:**

Presentations must be delivered in Hindi or English only. The use of Hinglish (a mixture of Hindi and English) is strictly prohibited.

#### **5. Judging and Decision:**

The decision of the judges is final, and participants will be provided with their score sheets after the event.

#### **6. Anonymity:**

Participants must not reveal their identity or the name of their college in any document or during the presentation. Violations of this rule will result in disqualification.

#### **7. Rule Changes:**

The Organizing Committee reserves the right to change the rules at any time as deemed necessary.

## **JUDGING CRITERIA**

1. Relevance to the theme
2. Originality of the proposed solution (No plagiarism—disqualification if found)
3. Clarity of the issue and strategy presented
4. Depth of research and analysis
5. Innovation in the proposed policy
6. Feasibility and practicality of the policy
7. Presentation clarity and engagement
8. Depth of policy understanding
9. Innovation and strategic thinking
10. Ability to respond effectively during the Q&A session
